*In accordance with that stipulated in Article 29 of Law 222 of 1995, the SURA Business Group hereby presents its Special Report:*

**THE SURA BUSINESS GROUP'S STRUCTURE**

Grupo de Inversiones Suramericana S.A. is the controlling company of the SURA Business Group.

As a Business Group, Grupo SURA has a presence spanning a total of 10 countries in Latin America and whose strategic focus is on providing its financial services, namely insurance, pensions, savings, investment, asset management and banking. Its shares are listed on the Colombian Stock Exchange (BVC) and the Company is registered with the ADR Level 1 program in the US.

As of December 31, 2024, for the purposes of drawing up this Special Business Group Report, Grupo SURA was comprised of 70 companies, distributed among controlling, directly owned and indirectly owned subsidiaries (the latter through its directly owned subsidiaries).

For the year ended on December 31, the Companies carried out transactions amongst themselves on an occasional basis, and both these, and those performed with third parties, were carried out in the best interests of each of the Companies while ensuring that these were performed under competitive market conditions, acknowledging the synergies existing as a Business Group and protecting the contractual balance of such.

The operations and decisions of the Grupo SURA Companies were not adopted under the influence or in the exclusive interest of its controlling company. Indeed these were carried out or made, or ceased to be carried out or made, for the purpose of creating added value for the entire Business Group, in the best interest of each of the controlled companies involved in said transactions.

The transactions between the companies belonging to the SURA Business Group were carried out pursuant to all applicable legislation, the Related-Party Transactions Framework Policy as well as other applicable internal rules and regulations.
